- Creating a scientific network to activate the scientific and specialized capacities of scientific centers and human rights thinkers.



• Proposing suitable structures for the development of sustainable and continuous scientific cooperation between human rights activists and thinkers with an Eastern approach.


Providing the basis for cooperation and understanding in order to propose human rights


